Since July 2013, the Illinois Department of Public Health (IDPH) and Chicago Department of Public Health (CDPH) have jointly developed Crisis Standards of Care for our state.

The CIR Annex supports the IDPH ESF #8 Plan by providing guidance to Illinois emergency response stakeholders on crisis care and resource allocation for patients during a catastrophic incident. It also outlines the state-level response when local, regional or state healthcare systems are incapacitated.
